

## **45<sup>th</sup> Special Report**

### **Human Rights Violations Following Students' Demands for Their Rights**

15th June 2001

#### **Introduction**

It is to be recalled that in its 42nd special report entitled "An Appalling and Dangerous Violation of the Rights of Students" and dated 21 April 2001, EHRCO had stated that students of the Addis Ababa University were brutally and dangerously attacked despite the fact that they had peacefully presented their legitimate demands beginning from 10 April to the concerned authorities of the government and the University.

Both the University's administration and the Minister of Education had then condemned the illegal actions of the police. While the Minister, Woizero Genet Zewde stated that "the entry into the University's campus of the police without any permission was wrong", the University's deputy president, Dr. Engineer Hailu Ayele, on his part, stated in no uncertain words that "the entrance of the police force into the campus without the knowledge of the university and the violent actions it took against the students who were then discussing their demands was illegal (taken from Addis Zemen of 3 April 2001). However, because of the unwillingness of the concerned government authorities in subsequent days to give appropriate responses to the students' demands, the problems became ever more compounded.

In the special report mentioned above, EHRCO had promised to issue a series of detailed reports regarding the human rights violations committed against students and other citizens in connection with the student crisis. Accordingly, this special report presents those violations that EHRCO has been to collect and verify. Even though EHRCO has collected information about much more numerous and serious violations than reported here, its efforts to verify these reports have not been satisfactory because of the unfounded allegation made against it by different government authorities and bodies and, as a result, the fear of informants to come forward and provide it with reliable information. As government officials and bodies alleged that EHRCO, under the pretext of teaching about human rights, incited the students into violence and attempted to divide them along tribal lines", many individuals and organizations could not dare to cooperate with EHRCO in its efforts to gather accurate information. Moreover, victims of the riots who were then hospitalised were prohibited from giving any information as they were under police custody. Journalists or others were strictly forbidden to take cameras with them to the hospitals. On 26 April 2001 a group of EHRCO staff that went to Yekatit 12 Hospital to talk to some victims of police brutality encountered a very difficult situation. These investigators of EHRCO did submit their official letter of cooperation to the Hospital administration and were allowed to talk to the victims. As they were talking to the victim's police detained and took them to wereda 13 police station. They were detained there from 10:00 in the morning until they were released on bail at 7:30 in the evening.

The following table is revealing in that the groundless accusations made by government authorities against EHRCO and unlawful restrictions of its activities had hindered the usual task of EHRCO. The table compares the violations that EHRCO was able to ascertain with those reported by different governmental and non-governmental bodies.

Even though the hurdles encountered by EHRCO still persist, it plans to continue to gather the necessary information in this regard and with the view of reporting to the public, the government and all those concerned. In this regard, EHRCO would like to appeal to all individuals and organisations to assist it by providing relevant information.

### Human Rights Violations Following the Students' Demands for Their Rights

In its 42nd special report on the issue, EHRCO had indicated what it considered to be the main causes and solutions of the problem. EHRCO is still of the belief that the demands of the Addis Ababa University students are based on their constitutional rights and, as such, should be responded to accordingly and unconditionally. Nor does EHRCO believe that the government will find the students' other administrative demands difficult to respond to. However, different government bodies have been taking actions they deemed appropriate in resolving the problems. But the measures taken have aggravated the problems rather than solving them. Because of this, a riot exploded in Addis Ababa on 18th of April 2001, resulting in the loss of many lives and public and private properties worth millions of birr were destroyed and looted. EHRCO had in the same report condemned the riots, which are in no way connected to the peaceful demands of the Addis Ababa University students, in the strongest of words and had suggested that the government take a strong legal action on the culprits.

The conserved government authorities, however, took illegal measures that have exposed many students, members of political parties, members and supporters of EHRCO and other citizens to death, wounding by gunshots and beatings, detentions and other forms of repression.

#### a) Students and Other Citizens Killed by Armed Units

The measures taken by the armed units in violation of article 14 of the constitution of the FDRE, which states, “Every person has the inviolable and inalienable right to life, the security of person and liberty” and article 15, which states that “Every person has the right to life. No person may be deprived of his life except as a punishment for a serious criminal offence determined by law.”

Moreover, in contravention of those international provisions adopted and ratified by the FDRE government such as Article 6(1) of the Universal Declaration of Human Rights and Article 4 of the African Charter of Human and Peoples Rights, armed government agents killed many people. Even though the number of people killed is higher than indicated here, EHRCO was able to collect and verify information about those contained in Table 2 below:

#### b) People Injured by Beatings or Bullets

As of April 11/2001 armed soldiers, in violation of article 5 of the universal Declaration of Human Rights, which states “No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment”, Article 7 of the International Covenant on Civil and Political Rights, Article 4 of the African Charter on Human and peoples Rights, and Article 18 (1) of the constitution of the FDRE, have caused various injuries to many individuals. Using sticks and rifle butts, these armed soldiers have caused heavy physical injuries especially to many students of the Addis Ababa University who were presenting their demands peacefully and within the bounds of their campuses. This violent measure by the police was later made to include wounding by gunshot beginning from 16/4/2001. EHRCO was not able to establish the exact number of the victims of this violent act, the following table shows those that it was able to ascertain so far.

### C. Detained Students and others

Following the loss of lives and destruction of property in the aggravated riot of 18th April 2001, various government bodies issued a series of statements. One of these authorised the Federal police to take measures it deemed necessary and make arrests as of 18/4/2001. This statement contravenes Article 9 of the Universal Declaration of Human Rights, Article 9 of the International Covenant of Civil and Political Rights, and Article 17(2) of the FDRE constitution that provides "No person may be subjected to arbitrary arrest, and no person may be detained without a charge or conviction against him". Measures being taken by the police since 19 April 2001 have been in violation of these provisions.

At the time that this special report was being prepared by EHRCO, student leaders and members of opposition political parties and other individuals whose names appear in table 4 below have been detained in military barracks and prisons which are located far away from their permanent residences. None of them have been brought to a court of law. The parents and families of the detainees were unable to find their whereabouts, and those few who did know are denied their right to visit the detainees. The detainees were prohibited from putting on shoes. Moreover, they still put on the clothes in which they were detained. This obviously could become hazardous to their health. From information obtained by EHRCO, these detainees are suffering from malnutrition and various diseases, while some have already died.

## Conclusion

The measures the government has been taking since the first week of April against the Addis Ababa University students who presented their demands peacefully, other persons and members and leaders of political parties are aggravating the overall situation. As described in detail above, many citizens have been illegally arrested by police and it has been impossible to establish their whereabouts. Information reaching EHRCO indicate that citizens in various prisons and detention centres have been subjected to torture and degrading treatment purported to extract self-incriminating information, some are reported to have died due to lack of sufficient food and different diseases. Moreover, among the detainees listed on table 4 above

1. many of them are students or self-employed.
2. many others are less than 18 years of age.
3. the majority were detained in places where no riot occurred, many others were arrested at night from their houses.
4. the majority were tortured by the police.
5. EHRCO has ascertained that most did not appear in court in 48 hours and that they were forcefully taken to places their families did not know have all created untold sufferings.

Reiterating that it will try all it can to investigate in detail all illegal measures taken by the government and the results thereof, EHRCO would like to make the following urgent call to the Ethiopian public, the government and all concerned:

### 1. To the Public

- Individuals and organizations to cooperate and help EHRCO's endeavours to collect and investigate the illegal measures being taken by government against students of Addis Ababa University and the damages caused by these illegal government actions.

### 2. To the Ethiopian Government

- Bring government officials and armed personnel who violated the rights of the Addis Ababa University students who presenting their demands peacefully.
- Create conducive conditions for the smooth process of learning teaching and research by meeting the legitimate demands of the students.

- Urgently stop the hitherto harassment, intimidation and detention of students so that they can resume their discontinued classes.
- Urgently bring detainee students, members of political parties and other citizens to a court of law, permit them to meet their family members, lawyers and to be provide them with the necessary food, medical and all other humanitarian assistance, and
- Provide the families of those university students who lost their lives or were injured by the human rights violations during the student crisis with appropriate assistance in accordance with available resources.

### **3. To Individuals, Representative of Foreign Governments and Organisations**

- To all those representatives of governments, individuals and organizations residing in Ethiopia or elsewhere and who are committed to the establishment of a democratic system, rule of law and due process, and the respect and protection of human rights and fundamental freedoms, to write to the following Ethiopian government officials and organs in support of EHRCO's demands.
