An Ethnic Conflict Flared up in West Harrarghe Zone 71st Special Report

30 December 2003

Introduction

Since the coming into effect of ethnic and language based division of administrative units, several ethnic and religious conflicts have occurred in many parts of the country. The conflicts between Amhara and Oromo, Oromo and Somali, Oromo and Gedio, Wolayita and Gamo, Wolayita and Sidama, Anuak and Nuer, Surma and Dizzi tribes can be cited as examples. As a result of these conflicts several people were killed and wounded and property worth millions was damaged.

EHRCO has investigated the conflicts when they occurred and reported its findings in its regular and special reports. It also urged all concerned bodies to appreciate the seriousness of the situation and take the necessary measures that would bring about an end to these series of clashes before they spread all over the country and cause irreparable damages. However, due to the failure of all concerned government bodies to take measures, ethnic conflicts have continued to arise in increasing gravity and frequency. One of such conflicts recently broke out between Oromo and Somali tribes in West Harrarghe Zone, Meisso wereda. Several persons were killed and many sustained injuries; and property was destroyed. The following is an account of the cause of the conflict and the consequent damage.

The Cause of the Conflict

Both Oromo and Somali Regional states have administered the Meisso wereda of West Harrarghe at the same time since 1992. The Somali Regional State has in the wereda, councils of wereda and kebele administration as well as a police station that all give services to Somalis living in the wereda. Likewise the Oromo Regional State has all the three administrative establishments for the Oromos living in the wereda. The Meisso wereda is referred to by the Oromo Regional State, as "West Harrarghe Zone Meisso wereda" while the Somali Regional State named it "Shinele Zone Meisso wereda". The market day of the Oromos in the town of Meisso is on Tuesdays whereas that of the Somalis is on Thursdays. As there have been

constant fears that conflicts might suddenly break out as a result of frequent disputes between members of the two ethnic groups, Oromos do not go to the market on the market day of the Somalis and neither do the Somalis on the market day of the Oromos.Previous incidents of clashes were being resolved through negotiation and reconciliation among local elders from both tribes.

Since September 2003, rumors have circulated among the residents of the wereda about the Federal government's intention to incorporate the Meisso wereda in one of the two regional states through a referendum. Following this, residents of the wereda form both tribes have started voicing their respective claims on the different kebeles of the wereda. Starting from early November, there have been incidents of clashes initiated by Somalis who demanded to have a share from the revenue collected as duty from *Chat*, a local stimulant. In one of these clashes, a man belonging to the Oromo tribe was shot dead by the Somalis. Then, the clashes escalated and continued until 18 November 2003 and resulted in the death and injury of several people and damage to property. The specific facts are presented in the tables below.

Rape

W/ro Telfa Hadji Hassen is a resident of Meisso wereda Hardi kebele. She was gang raped by members of the Oromo tribe on 16 November 2003 while she was feeding camels in the field. The rapists took away twelve of her camels. The camels however were later given back to the woman as a result of the negotiations between elders of the two tribes.

<u>Displacement</u>

Several people were displaced from their villages as a result of the conflicts. The displaced persons did not get assistance either from the government or other relief agencies until the time that this report is prepared.

The conflict was made to stop temporarily by the involvement of the national defense forces. However reports reaching EHRCO confirm that another round of large-scale clashes have broken out and are still going on.

Conclusion

As stated above, in the conflict that flared up in West Harrarghe zone Meisso wereda, several people were killed and injured and a considerable amount of property was destroyed. Ethnic conflicts like this one are not new in the area. It would have been possible to avoid these casualties had timely and lasting measures been taken by the pertinent government bodies. It is not difficult to tell that further damages would ensue on human lives and property if the government does not take the necessary measures. Thus EHRCO appeals to the federal government and the respective regional state governments to come up with speedy and peaceful solutions to the problem and bring an end to the conflicts. EHRCO particularly urges the government:

- to give due attention to the border dispute between the two regional states on some kebeles in Meisso wereda and investigate other causes of the conflict.
- to take lasting legal measures that could help to avoid further damages.
- to bring to justice those who are involved in the killings and other human rights violations.
- to give assistance and rehabilitate those displaced due to the conflicts.

EHRCO also calls on those who stand for peace and the rule of law, to exert pressure on the Ethiopian government to seek solutions, which are legal and based on the Federal Constitution, by writing to the government bodies and officials listed below.
