Human Rights are not respected = There is no democracy 92^{nd} Special Report

EHRCO announced in its report No. 90 that following the shooting by the security forces to stop the protest that arose as of Nov. 1/2005 in A.A. 34 persons have died, 62 persons have been wounded by bullet shots or beating and a number of others have been detained at different places great damage has been done to properties too. In the conflict that occurred as of Nov. 1/2005 12 additional persons have been killed without trial; 9 persons are missing and 34 persons have been detained as detained out here below.

A) Killing

Contrary to the provision of article 15 of the constitution of the Federal Democratic Republic of Ethiopia, which states, "Every person has the right to life. No person may be deprived of his life except as a punishment for a serious criminal offense determined by law" and contrary to article 3 of the Universal Declaration of Human Rights which Ethiopia has ratified which states that "Everyone has the right to life, liberty and security of person" the following persons have been killed by the security forces.

C) Illegal Imprisonment

Contrary to the provision of article 17(2) of the constitution of the Federal Democratic Republic of Ethiopia that states "No person may be subjected to arbitrary arrest, and no person may be detained without a charge or conviction against him", and contrary to the provisions of article 9(1) of the untitled nations International Covenant on civil and political rights that states "Everyone has the right to liberty and security of person. No on shall be subjected to arbitrary arrest or detention. No one shall be deprived of his liberty except on such grounds and in accordance with such procedure as are established by law", The following persons have been jailed illegally.

Conclusion

Following the result of the May national and regional elections the steps taken by the government, contrary to the provisions of the constitution and those clearly put down, as well as contrary to the fundamental human rights stated in the rules of the international covenants that Ethiopia has accepted are worsening the situation and bringing about damages to the life and property of citizens. In particular the illegal steps being taken against elderly people, women, children, political parties that are operating after being organised and private press, are darkening the hope of the democratic process that was supposedly flourishing. The government should therefore, be prepared and show good will to give proper response to the legitimate questions raised by the public, before the situation worsens and the country finds itself in a morass that it cannot extricate itself from

Among those bodily injured there is a youth of 20whose leg has been amputated and is still under treatment in hospital, another youth of 20 whose belly was pierced by a bullet shot is defecating through his belly although he was hospitalised but the wound has not headed.

EHRCO, therefore proposes the following to the government:

- 1. Regarding injustices committed on Tikimt 22,23 and 24/1998 Eth. Cal. the factual situation should be investigated by a neutral and independent body and those who perpetrated the injustices should be brought to justice.
- 2. The injured families who lost their heads of families, their children and their parents, should be composed morally and materially.
- 3. Those bodily injured who are suffering because of lack of medical treatment and those who find themselves in difficulties because of the injuries inflicted upon them, should be given medical treatment and aid to re-establish themselves.
- 4. Leaders of opposition political parties, members and supporters of such parties, journalists, publishers, others who fight for human rights and peaceful citizens who are in jail should be released unconditionally so that there may be peace and political stability in the country.
- 5. Political differences should be dealt with trough discussion and through a spirit of tolerance and a stop should be made to hateful propaganda.

EHRCO calls upon national and international organisations, as well as representatives of governments and international organisations standing for the respect of human rights, for the development of democracy and for the establishment of the sovereignty of the law, to write in as much as possible to the following governmental bodies and officials so that the latter may take corrective measures.
